

**APPLICATION FOR ANNUAL PERMIT
NON-HIGHWAY VEHICLE**

Pursuant to Title 6, Chapter 5 of the Mt. Morris Village Code, certain non-highway vehicles may be approved for use on specified public streets, roadways and alleys of the Village of Mt. Morris where the posted speed limit is 35 miles per hour or less. Non-highway vehicles may not be used on any toll road, interstate highway, controlled access highway or other highway or road under the jurisdiction of the State of Illinois. At present, “non-highway vehicles” include only those vehicles defined under law as “recreational off-highway vehicles” or “golf carts” “Recreational off-highway vehicles” mean any motorized off-highway device designed to travel primarily off-highway, 64 inches or less in width, having a manufacturer's dry weight of 2,000 pounds or less, traveling on 4 or more non-highway tires, designed with a non-straddle seat and a steering wheel for steering control, except equipment such as lawnmowers. “Golf carts” mean any vehicle specifically designed and intended for the purposes of transporting one or more persons and their golf clubs or maintenance equipment while engaged in the playing of golf, supervising the play of golf, or maintaining the condition of the grounds on a public or private golf course. Applicants shall be required to comply in all respects with Title 6, Chapter 5 of the Mt. Morris Village Code and the Illinois Vehicle Code, including the obligation to purchase an annual permit. Violations may result in suspension or revocation of the permit and significant fines and other penalties.

MORRIS HARMLESS WITH RESPECT TO, ANY AND ALL CLAIMS, PENALTIES, COSTS, JUDGEMENTS, SETTLEMENTS OR CAUSES OF ACTION RESULTING FROM OR ARISING FROM THE OPERATION OF THE APPLICANT’S NON-HIGHWAY VEHICLE ON THE STREETS OR OTHER PUBLIC WAYS IN THE VILLAGE OF MT. MORRIS.
